- 1. **Equity & Diversity** Nothing to report, meeting in a couple of weeks.
- Safeguarding Course booked at Elsecar on 11/10/2023, 6-9pm. LP reported that the YCB are now wanting to hold one course annually at Headingley and DW has told them this will not work. LP reported an ongoing complaint from Higham regarding a member of Barnsley Woolley CC.
- 3. **Committee positions 2024** all members agreed to continue.
- 4. **Play Cricket** MB stated that 3500+ players were registered and that adding Rule 47 had been helpful. Overall, the reporting of results had been better but there were still issues with one or two clubs.

## 11. **AOB**

- DW said there was a disciplinary hearing pending regarding incidents in the recent Higham v Handsworth Juniors fixture. DW to arrange to meet members of Handsworth Juniors in due course.
- MB enquired about the current position with the Wentworth ground. NW had been told it would be ready for April 2024, but he very much doubted it.
- RF queried why Sheffield United had added 5 runs to their score in a recent fixture v Rotherham Town on 2/9/2023. He confirmed that neither scorer had scored electronically and the score had been changed from 223 to 228. DW reminded members that SU had suspended points pending and said that he would write for an explanation.
- MS referred to the recent Billy Oates Cup Final at Oughtibridge and said he was disappointed with the attendance. He thought we should consider paying more to the lower Clubs who host finals, especially where there are other Finals on the same day.
